#### I. Replacement of Members

Mr. Inoue, Chairperson of the Committee, reported that Mr. Suzuki and Mr. Tanaka had resigned from the Committee. Mr. Taguchi and Mr. Tokita applied for the new members of the Committee, and both of which were approved unanimously.

## II. About the Final Report of the Project Team to Promote PvP Settlement for FX Transactions by Trust Funds

Mr. Ohkuma reported that the final report which summarized the activities of the Project Team to Promote PVP Settlement for FX Transactions by Trust Funds had been approved at its meeting held on March 17. He also reported that the final report had been published on the TFEMC website on April 10, along with the English summary document.

#### III. About expenses for BCP project in 2025

Mr. Inoue, Chairperson of the Committee, reported that the Sub-Committee on BCP planned to send invoices for operational expenses regarding BCP project to its participants in April. He also explained that the due date for operational expenses would be the end of May, and no particular objections were raised.

### IV. Other

Mr. Kohashi, Vice-Chairperson of the Committee, reported that the Japanese version of FX Global Code (hereafter, "Code") and the summary of the revisions of the Code had been published on the TFEMC website. He also reported that the Sub-Committee on Code of Conduct would encourage those who had already adhered to the previous Code to consider re-adherence to the revised Code. In addition, he explained that the Sub-Committee, together with the Sub-Committee on Buy Side, would consider the work plan on how to encourage those who had not adhered to the Code to consider adherence.

Mr. Hirashima presented the status of the implementation of PvP Settlement for FX transactions by trust funds, insurance companies, and business corporations in Japan, and explained that there might be room for disseminating PvP Settlement into FX settlement operations by insurance companies and business corporations. Mr. Hoshino asked if there were any areas where delays in implementing PvP Settlement into FX settlement were seen as problems in the global discussion, and Mr. Hirashima explained that the issue was how to reduce settlement risks for non-CLS eligible currencies such as the Chinese yuan.

Mr. Terawaki explained that with regard to the policy for audits, he would establish a rotation scheme, which consisted mainly of members who were not members or chairpersons of Sub-Committees, and to select a member in charge of audit from among them for each fiscal year, and no particular objections were raised. Mr. Hoshino asked about the tasks of the audit, and Mr. Terawaki explained the specific tasks of the audit and reported that a procedure manual was being prepared.
