## Minutes of the 138th Meeting

# of the Tokyo Foreign Exchange Market Committee (TFEMC)

#### I. Activities of Sub-Committees

#### 1. Sub-Committee on Committee Steering

Mr. Takeuchi, Secretary of the Committee, reported that the international conference call among the secretariats of each foreign exchange market committee signaled a growing global interest in the derivatives provisions of the Dodd-Frank Act. Mr. Inoue, Chairperson of the Sub-Committee, announced that at the Annual General Meeting on February 1<sup>st</sup>, the activities of each Sub-Committee and the statement of revenues and expenses of the Committee in fiscal 2010 were going to be presented.

#### 2. Sub-Committee on BCP

Mr. Kuzuhara, Associated Member of the Committee, reported the summary of the questionnaire of the joint BCP exercise held on November 17<sup>th</sup>. As for the future tasks, he reported that the Sub-Committee should conduct a more practical exercise under more diverse and unannounced disaster scenarios and should unify the definition of each progress phase among the markets. As for the BCP-dedicated web site, he recommended to maintain it regularly and improve its functions for cell phones.

#### 3. Sub-Committee on Education

Mr. Kawano, Chairperson of the Sub-Committee, distributed the notice of the upcoming Forex Seminar. Based on the consensus that the notice should be distributed widely in order to increase the seminar participants, the Committee discussed the list and way for distribution.

#### 4. Sub-Committee on E-Commerce

Mr. Takagi, Chairperson of the Sub-Committee, reported that the Sub-Committee had discussed the impact of the increase in the volume of electronic trading, especially that of high-frequency trading, on the Tokyo foreign exchange market and the recent developments in margin trading.

#### 5. Sub-Committee on Settlement

Mr. Komatsu, Chairperson of the Sub-Committee, reported that the Sub-Committee had held a workshop on post-trade processing of foreign exchange derivatives. It was also reported that the Sub-Committee had confirmed their commitment to study the OTC derivatives regulatory reform in Europe and the United States and the developments in overseas clearing houses and that they had improved their understanding on the settlement of OTC trading.

#### II. Others

After the Committee meeting, a lecture and question-and-answer-session were held by a guest lecturer from an American law firm on the derivatives provisions of the Dodd-Frank Act.
